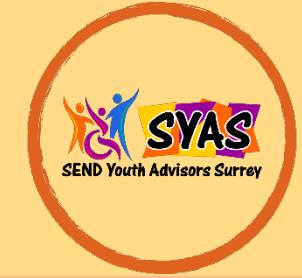

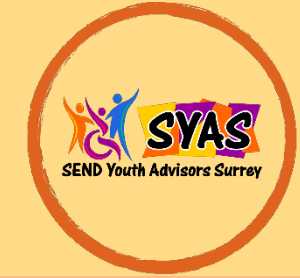

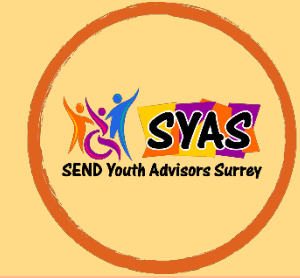

Action Cards

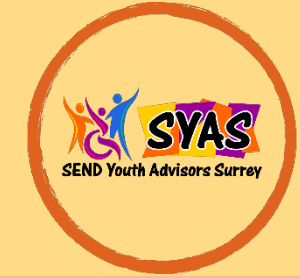
From your discussion over the past couple of months, we have identified three possible Action Cards that you might want to raise:

- The UVP Team need to create more accessible social media posts for young people with additional needs and disabilities.
 - E.g. a number of posts still use images without alternative text etc.
- Virtual lessons need to be more accessible for young people with additional needs and disabilities.
 - What specific changes would you like to see?
 - E.g. More active teaching styles, content provided in advance, reversal in the reduction of teaching hours at college
- NHS 111 needs to have staff who are trained to help and signpost to appropriate services (or have the appropriate resources to support) young people with additional needs and disabilities.
